PDF ( PDF ( PDF (.pdf).Mexican President Enrique Pena Nieto made a surprise visit to the border city of Ciudad Juarez on Thursday in an effort to curb drug-related violence in his country. At the center of the visit: a meeting with the area's chief prosecutor, who reportedly told Pena Nieto that the mass killing of women and children in Juarez was "a problem." According to the Washington Post, Mexico's new president has been "profoundly shaken" by the drug violence plaguing his country. He told the Mexican Council of Human Rights on Thursday that "it is necessary to find a comprehensive solution to the problem, and that we will develop a series of measures to stop the violence." After visiting the Juarez International Bridge, the mayor of Juarez, the murder capital of the world, and the border city of El Paso, a statement on the visit said: "We are determined to commit ourselves to a change. We are committed to a change of the strategy, an end to the violence, an end to impunity, an end to corruption and a commitment to promote the rule of law." Juarez Mayor Enrique Serrano Fuentes said he supported the ongoing investigation by Mexican authorities on the disappearance of 43 students in the neighboring state of Guerrero. But he said that if investigators conclude that the disappearances are a crime, "we will prosecute." The disappearances occurred as Mexico was stepping up its war on drug cartels and capture of drug dealers. Authorities were "looking for a way to strike a balance," according to a Mexico expert who spoke with the Washington Post. He said the balancing act depends on whether the government is operating under the assumption that "the state has an obligation to every citizen." "Just because you close down one avenue of crime doesn't mean you're going to keep the other avenues open," he said. He continued: "You might have to work with criminal groups, help them, let them be part of your decision-making, and treat them as partners. Even though they are criminals. They might be a lot less dangerous than other groups and they might be that much more motivated to work with you."
